Ulysses Club GB Privacy Statement: How the club uses your information

Here at Ulysses Club GB (UCGB) we take the privacy of our members data seriously and will only use your personal information for club administration purposes and for communicating with you about your membership. Only the Committee members will be able to access your details. We will never share or sell your data without your prior permission.

Personal information we collect and how we use it

When a member joins the club, we'll collect some personal details in order to:

- manage your membership including access to a private password-protected online forum;
- contact you about events and activities (usually by email or text);
- email you copies of our newsletter;
- keep lists of attendance at club AGMs and other events;
- passing on the email address &/or phone number of individuals to another member for social contact purposes. For this to happen the specific consent of the individual must be provided.
- create a marker on a members' distribution map. The markers are **not** in the specific locations of members but are in the approximate area only. Clicking on the usernames below the map will give the **general** location of each member.

The information you provide will not be used for other purposes without your permission. We will never share your information with a third party outside the club.

The types of personal data we collect and store are:

- Name
- Club user name
- Address
- Telephone number (s): landline &/or mobile
- Email address
- Date joined
- Subscription details (e.g. paid for 1 or 3 years)
- Details of how members were introduced to the club (e.g. friend, website etc.)

Your rights

You have various rights in relation to your personal information:

- to see the personal information we hold on you (via the Secretary);
- to withdraw consent for storing your information;
- to change your information at any time;
- to tell us how you prefer to be contacted.

It is important that we keep accurate records so we will appreciate you informing the Secretary of your information change.

Keeping and storing your data

Your data will be stored securely in an electronic format on a spreadsheet and on paper. Archives (file back-ups) of the club database are stored securely for data security reasons for no longer than 2 years.

If your membership ends your data will be removed from our membership database as soon as the Secretary is informed.
